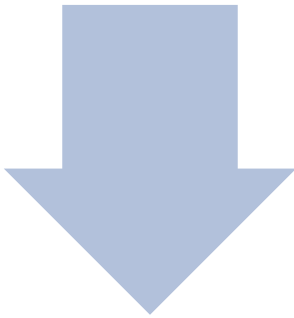


How to Register for Programs and Courses

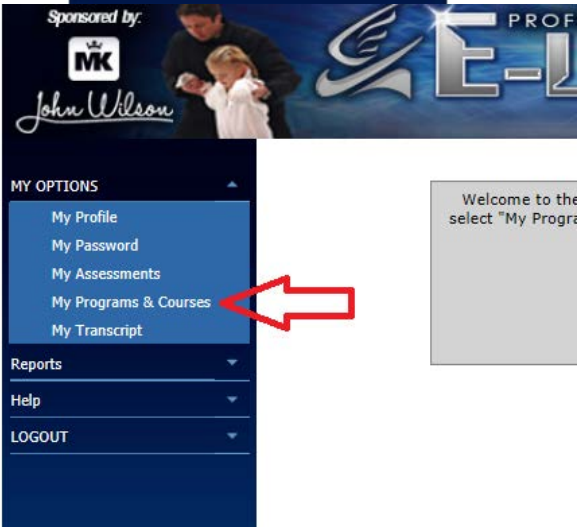
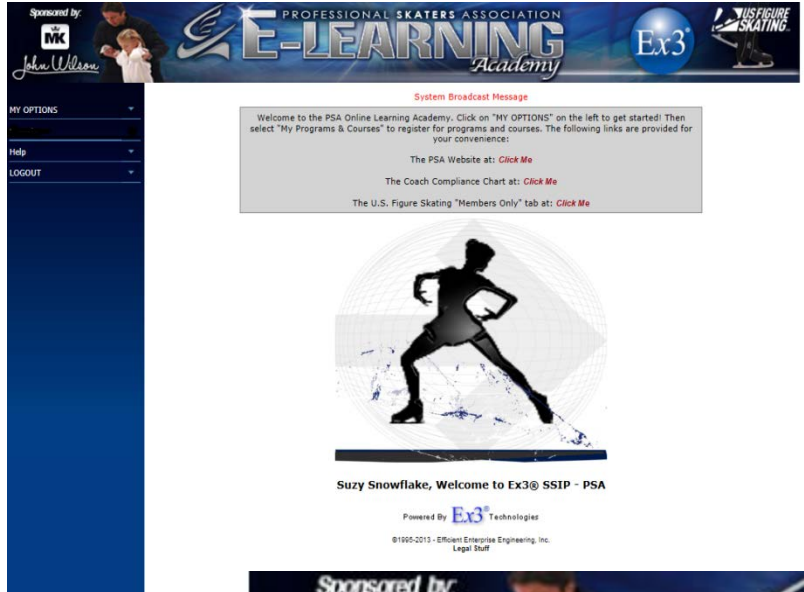
After logging in, you will see the screen on the right.



Click on My Options

Select Season: Choose from drop down list. Click on Program Name to highlight. If you have not paid the yearly subscription fee, you will be prompted to do so. Then continue with directions below.



Click on View Requirements to see course descriptions and prices.



Click on Select to choose courses and proceed to purchase.

Program Requirements

1) Must be an associate, intern, or full member of PSA. 2) Must have attended a PSA approved education program or completed four (4) e-learning courses within one (1) year prior to taking the exam. The exam is composed of 100 multiple choice and T/F questions. The Coaches' Manual is available for purchase from the PSA office to assist in preparation for the exam.

PSA BASIC ACCREDITATION RATING EXAM	BA-100 Exam	When the candidate registers to take the exam online they will receive an email stating their exam is "waiting for approval." This means a PSA web administrator must check to see if the requirements have been met before approving the exam. Once approved the candidate will be able to access the exam the next time they log in. A study guide is not emailed to the candidate as it will be available for purchase from the PSA office once the candidate is approved for the exam. The passing percentage for the online test is 80%.
